THIS IS an Application for judicial review of a decision of a Case Officer of Citizenship and Immigration Canada dated January 19, 2012 wherein the Applicant's application for a permanent resident visa was refused;

I HAVE read the materials filed by the parties and the Certified Tribunal Record and I have heard submissions by Counsel for each of the parties;

I AM returning the matter for reconsideration by a different Officer on the narrow ground that the Officer making the decision appears to have focused only on the T4A slip provided and not the other materials including a letter from the Applicant's employer, pay cheques and Service Canada's Labour Market Opinion. In balancing all the evidence the conclusion may or may not be the same, however, from the decision before me it is not clear that all the evidence was considered.

THEREFOR, THIS COURT'S JUDGMENT is that:

1. The application is allowed;
2. The matter shall be redetermined by a different Officer;
3. No question is certified; and
4. No Order as to costs.
